

Largest 150 U.S. Ballet & Classically Based Companies & Financial Scope of the Industry

JUNE 2022



Report Summary

The following is Dance Data Project®'s fourth annual and most comprehensive study to date of the largest U.S. ballet companies. For the 2022 Report, the DDP research team produced rankings by size not only for the **Largest 50** and **Next 50**, but also an **Additional 50**, thus ranking a total of 150 U.S. ballet companies. The *Largest 150 U.S. Ballet & Classically Based Companies & Financial Scope of the Industry Report* gives information on the aggregate expenditures of all three groups, demonstrating the considerable economic contribution of the classical dance economy, as well as the significant disparity in size between the largest few companies and the rest.

In DDP's <u>2021 Largest 50 U.S. Ballet Companies & Scope of the Industry Report</u>, we determined that while the **Largest 50** totaled approximately \$665,000,000 in operating expenditures, the **Next 50** aggregated budgets comprise only 7% of that figure, demonstrating a notable disparity in resources favoring the few largest companies.

We believe it is important to gather momentum in surveying and comprehending the entire landscape of ballet in the United States. This year's Largest 150 U.S. Ballet & Classically Based Companies & Financial Scope of the Industry Report will be the first of DDP's reports to reckon with the impact of COVID-19 on the performing arts in general, and dance in particular.

This year's Largest 150 U.S. Ballet & Classically Based Companies & Financial Scope of the Industry Report covers the budgetary impact of the onset of the pandemic in early 2020, creating a rolling wave of shutdowns towards the end of the 2019-2020 season and continuing to affect the beginning of the 2020-2021 season¹. As of November 2020, Dance/NYC's research indicated that 47% of independent dancer workers were unemployed. According to the Bureau of Labor Statistics as reported by Dance/USA, dancer/choreographer unemployment overall in the industry rose to 45.6% for the period 2019-2020. As documented by Dance/USA, 75% of independent dance workers filed for unemployment and 44% of independent dance workers applied for relief grants from various sources during the pandemic. Generally during the pandemic, there was a sense of turmoil in the performing arts industry and most particularly in the dance world, the hardest hit of all performing art forms.

It should be noted that Covid mandates at a state, local and municipal level varied widely during 2020. Therefore, while some companies were almost completely shut down, or virtual, others were able to achieve some form of "normality." Combined with widely varying onset of fiscal year 2020 as noted in **Appendix D** (from April 1, 2019 through January 1,2020), the economic impact of the pandemic had a disparate and uneven effect on the industry, which should be considered when drawing conclusions from this Report.

Key Findings include:

DDP found that the aggregate expenditures for the **Largest 50** companies (as ranked based on FY 2020 data and compared to the Largest 50 ranked based on FY 2019 data) dropped by almost 12% from the previous year, totaling \$586,724,176. The aggregate expenditures for the **Next 50** totaled \$44,519,966, almost 8% of the **Largest 50** in FY 2020. In turn, the aggregate expenditures for the **Additional 50** was \$15,087,843, 34% of the **Next 50** in FY 2020 and only 2.5% of the aggregate expenditures for the **Largest 50** in FY 2020.

- The Largest 150 U.S. Ballet Companies operated with combined expenditures of \$646,331,985 in Fiscal Year 2020.
- The Largest 50 operated with 91% of overall combined expenditures, where the **Next 50** operated with 7%, and the **Additional 50** operated with 2%.

Year-to-Year Changes Within the Largest 50

Compared to the DDP Largest 50 Report published in 2021:

- American Ballet Theatre has dropped from #3 to #6.
- Two companies shifted off the **Largest 25**: Nashville Ballet (from #22 to #28) and Tulsa Ballet (from #25 to #30).
- Two companies were added to the **Largest 25** this year: Milwaukee Ballet (#23) and Ballet Hispánico (#24).
- Festival Ballet Providence (from #50 to #52) dropped out of the Largest 50.
- Ballet Magnificat! (#49) and San Antonio Ballet (#50) were added to the Largest 50 this year.

³ New York City Ballet is currently ranked by the company's budget alone and does not include expenses from School of American Ballet. NYCB and SAB expenses combined totaled \$98,545,769 in FY 2020. Overall, this is a 9% decrease from FY2019's combined budget by expenditure of \$108,367,309.

"Next 50" U.S. Ballet Companies

For the second year in a row, DDP ranked the budgets by expense of the "Next 50" U.S. ballet companies. The following are the companies that comprised #51-100 when the full sample was ordered by size of annual expenses. The Report refers to this group as the "Next 50" and also uses "Upper 10," "Upper 25," and "Lower 25" to refer respectively to #51-60, #51-75, and #76-100 of this list.⁶

For comparison: American Midwest Ballet (#51) had annual expenses \$22,628 less than Ballet San Antonio (#50) for Fiscal Year 2020.

Year-to-Year Changes

"Additional 50" U.S. Ballet Companies - Expansion of Survey

Last year, DDP surveyed 126 U.S. ballet companies to expand its coverage of the scope of the dance economy. This year, DDP surveyed 188 companies, an increase of 49%.

The expansion of our survey has allowed DDP to produce, for the first time, an ordering by budget expenditure of the "Additional 50" U.S. ballet and classically based companies. These are the companies that comprised #101-150 when the full sample was ordered by size of annual expenses.

For comparison: Utah Metropolitan Ballet (#101) had annual expenses \$2,923 less than Ballet Theatre Company (#100) for Fiscal Year 2020.

Section II: Scope of the Industry

Aggregate Expenditures

The **Largest 150** U.S. Ballet Companies operated with combined expenses of \$646,331,985 in Fiscal Year 2020.

The **Largest 50** U.S. Ballet Companies operated with combined expenses of \$586,724,176 in Fiscal Year 2020.

The **Next 50** U.S. Ballet Companies operated with combined expenses of \$44,519,966 in Fiscal Year 2020. For context, this is approximately 8% of the aggregate expenses for the Largest 50.

The **Additional 50** U.S. Ballet Companies operated with combined expenses of \$15,087,843 in Fiscal Year 2020. For context, this is 34% of the aggregate expenses for the Next 50 and only 2.5% of the aggregate expenses for the Largest 50.

The following figure places the yearly aggregate expenditures of the Largest 50, Next 50, and Additional 50 side-by-side to demonstrate the considerable difference in scale.

Aggregate Expenditures





From 2019 to 2020 the aggregate **Largest 50** expenses **decreased** by 10.8%, compared to the 4% increase from 2018 to 2019 and 5% increase from 2017 to 2018.

From 2019 to 2020, the aggregate **Next 50** expenses **decreased** by 4%, compared to the 11% increase from 2018 to 2019 and 6% increase from 2017 to 2018.

From 2019 to 2020, the aggregate **Additional 50** expenses **decreased** by 13.6%, compared to the 5% increase from 2018 to 2019 and 10% increase from 2017 to 2018.





AGGREGATE EXPENDITURES by percentage of Additional 50






Distribution of Expenditures

The pandemic challenged the dance industry, hindering its ability to provide a "normal" experience. Some companies turned to virtual seasons, while others had to close their doors. In many cases, company finances drastically changed in fiscal year 2020 (the first year addressing the impact of COVID-19). Previously, individual company expenses did not deviate greatly from year to year. After integrating FY 2020 data to the averaged expenses, there is no longer a consistent year to year trend. Due to the impact the pandemic had on expenses, the data is now skewed. DDP explored averaged data to show the effect of FY 2020.

"A completely unpredictable series of events triggered by the initial onset of Covid and then subsequent surges, combined with how much freedom each State and city determined to permit for live performances, repeatedly stymied companies' ability to return to live venues, or prevented planned virtual or filmed performances. Dancemaking organizations reported more than 75 percent loss in ticket revenues relative to their pre-COVID season. And 82 percent of companies that toured reported they had not toured; those that were able to tour reported touring fees had fallen an average of 77 percent" (Dance/USA). These losses are reflected in the averaged budgets as shown above.

The following figures further show how the expenditures are distributed between companies within the Largest 50, Next 50, and Additional 50. For these figures, annual expenses were averaged for each company from 2017 – 2020 to capture the trend over time.

DISTRIBUTION OF EXPENDITURES Largest 50 U.S. Ballet Companies





In the **Largest 50** distribution figure, the first ten company budgets range between \$87,128,901 and \$14,679,527, while the remaining forty company budgets range between \$13,254,365 and \$1,470,191. There are "spikes" in this graph as some companies have changed rank due to drastic drops in expense budgets. For example, American Ballet Theatre dropped from rank #3 to rank #6. In FY2017, FY 2018, and FY2019, the company's expense budget was \$45,050,346, \$48,511,383, and \$49,002,829 respectively. From FY2019 to FY2020, ABT's expense budget dropped from \$49,002,829 to \$29,740,579, a decrease of 39% (\$19,262,250 decrease). Please see our *Nota Bene* on Page 15 of this Report regarding ABT's FY 2020 year (January 1, 2020), likely impacting it's ranking.

DISTRIBUTION OF EXPENDITURES Next 50 U.S. Ballet Companies




In past DDP reports, a steadily decreasing line indicated that as companies got smaller (size being defined by budget by expenditure), their averaged expense total decreased. Average company expenses and ranking are no longer related in this fashion. This report's **Next 50** distribution figure shows a range from \$1,655,922 (rank #52) to \$350,618 (rank #89) in budget by expenditure, including many "spikes." State Street Ballet jumped from #62 (FY2019) down to #86 (FY2020) as their budget by expenditure decreased by 47%. The company's averaged expenses were highly affected by this drop in budget by expenditure and thus produced a "spike" in the chart.

¹⁰ A "spike" is defined as a sharp rise in the frequency for a given variable, usually immediately followed by a decrease.

The **Additional 50** distribution figure shows a range from \$702,478 to \$101,937 in budget by expenditure. Similar to the **Next 50**, the **Additional 50** figure illustrates where averaged expenses "spike" and where company expenses dropped drastically in FY2020. Ballet Sun Valley dropped from #76¹¹ to #138, decreasing its budget by 76%.

Change in Expenditures

The following figures show the change in budget by expenditure for each company in the Largest 50, Next 50, and Additional 50 U.S. ballet companies from FY 2019 to FY 2020. Each dot in the figure below represents the change in budget. The "baseline" is at \$0, which if a dot were placed here, would represent no change in budget from FY 2019 to FY 2020¹². All dots above this line show an increase in expenses (green), where any dots below this line show a decrease in budget (red).

Company Specific Financial Findings:


NOTA BENE: While ABT has dropped in the DDP ranking for Fiscal Year 2020, from #3 to #6, **this rank change may be misleading**. ABT's budget year began January 1, 2020 and ended 12/31/2020. Thus, their \$19.2 million drop in expenses is likely due to experiencing 10 months of Covid-19 closures, v. for example New York City Ballet, whose budget year began July 1, 2019 (4 months of Covid related closings and impact), or Miami City Ballet whose budget year 2020 commenced May 1, 2019 and ended April 30, 2020 (2 months Covid/pandemic related closures). Therefore, until the full budgetary effects of the pandemic period are tabulated (likely DDP's fiscal 2023 report which will be produced in June/July of 2025), any conclusions based solely on ranking are inadvisable. Rather, American Ballet Theatre's budget decrease will likely be typical of reported companies' expenses for the year 2021, and 2022.

Company Specific Major Financial Findings:


- PHILADANCO! (#60) had the largest proportional **increase** in expenses in the Largest 100. The company's FY 2020 budget by expenditure, was 50% larger than its FY 2019 budget.
- State Street Ballet (#86) had the largest proportional **decrease** in expenses in the Largest 100. The company spent 47% less in FY 2020 than it did in FY 2019.

- 11 increased company expenses
- 33 decreased company expenses

Company Specific Major Financial Findings

- Chamber Dance Project (#123) had the largest proportional **increase** in expenses from FY 2019 to FY 2020. The company's budget by expenditure was six times as large in FY 2020.
- Ballet Sun Valley (#138) had the largest proportional **decrease** in expenses from FY 2019 to FY 2020. The company's budget by expenditure was 76% less in FY 2020.



Section III:

Operational Definitions, Methodology, and Limitations

Operational Definitions

Ballet Company

For the purposes of study, DDP defines "ballet company" as an organization that has both roots in classical ballet and a professional performing company. If a company (such as Alvin Ailey), defines its work as "ballet" then we honor their terminology. Note, however, that Alvin Ailey is also counted in our Modern and Contemporary ranking. DDP also considers factors such as if the company has an affiliated school that teaches pointe work and if the company commissions works by choreographers who also work with traditional ballet companies.

We also attempt to be respectful of how a company defines itself, so, for example, for our FY 2020 study, Hubbard Street Dance Company (HDSC), is not included as HSDC has indicated they do not consider themselves a "ballet company."

DDP remains generous and open-minded with the definition and recognizes that the art form is constantly evolving.

Largest 50

Originally in 2018, DDP published research utilizing the term "Top 50" to describe the 50 U.S. ballet companies with the greatest expenses. In 2021, we renamed it "Largest 50," keeping the definition but changing the name to denote purely size of expenditures rather than any judgements of artistic excellence or preeminence.

Methodology

DDP uses three sources for the financial information contained within this report:

- 1. E-filed Form 990's provided directly by the Internal Revenue Service (IRS), gathered and extracted by DDP's proprietary software
- 2. Third-party databases of Form 990 data, gathered and extracted by DDP's proprietary software and/ or DDP's research staff
- 3. Self-reported information, submitted directly by company officers or their independent auditor

This is the first year DDP used software automation to gather financial data. This Report examines the rankings created by company expenses for FY 2020. To verify its proprietary software works correctly, DDP applied the software to gather previously, manually-collected data presented in DDP's 2021 Report covering the 2019 fiscal year. The data extracted via the proprietary software was compared with the data set gathered manually by the DDP research team the year prior. The only discrepancies found were from self-reported data and, in one case, an error in the prior manual process.

The use of software automation has accelerated DDP's ability to collect and verify financial data, enabling a broader scope of companies to analyze.

Sourcing information directly from the IRS has enabled DDP to analyze data not yet available within third-party databases such as ProPublica, Guidestar, and Charity Navigator. In the case of this Report, data could be extracted from Form 990s filed in 2021 covering FY 2020 by directly pulling from the IRS, as many FY 2020 Form 990s are unavailable within these third-party databases.



Largest 150 U.S. Ballet & Classically Based Companies & Financial Scope of the Industry

Data quality is assured through the following process:

- 1. Financial information is extracted from the IRS data through software automation.
- 2. This information is directly validated against the data provided by reliable third-party databases (in this case, ProPublica).
- 3. All companies are contacted and given the opportunity to confirm or correct the validated information.

In the rare case where DDP's proprietary software disagrees with third-party databases, DDP researchers manually review the Form 990 data provided by the IRS. (Manual review can be done by accessing Form 990s through ProPublica, Guidestar, or Charity Navigator.)

Occasionally, companies physically submit their Form 990 instead of e-filing. In such cases, we manually collect information within third-party databases (ProPublica, Guidestar, and Charity Navigator) and send a request to the company to confirm the accuracy of the collected data.

This process was completed for the following Form 990s:

American Contemporary Ballet FY2020 Avant Chamber Ballet FY 2020 Ballet Hartford FY2020 Ballet Sun Valley FY2020 Ballet Vero Beach FY2020

Columbia City Ballet FY2019

Delta Festival Ballet FY2019 and FY2020

In some instances, DDP must rely on self-reported information. This happens primarily when companies do not yet have tax exempt status. This is a trend seen in smaller and newer companies. In order to include as many professional ballet companies in our scope, DDP gives companies the opportunity to self-report their finances.

There are three scenarios/circumstances in which DDP was forced to rely solely on self-reported information:

- 1. The company has submitted their Form 990 to the IRS, but the IRS has not yet processed it and made it publicly available. (This is the case for all companies for which DDP is missing FY 2020 Form 990 returns.)13
- 2. The company has not submitted their Form 990 to the IRS. NOTE: (DDP is unable to determine whether the company has not yet submitted its Form 990 or if it has not yet been processed.) This is the case for all companies for which DDP is missing FY 2020 Form 990 returns. 14
- 3. The company is not required to submit a Form 990. (e.g. it does not have tax-exempt status) DDP has flagged an additional 14 ballet companies, but due to lack of fiscal data they are not included in this report. 15

DDP has found in the past that sometimes a company will file more than one Form 990 for the same fiscal year. Typically, a later submission corrects and/or adds information to a prior submission. DDP uses only the most recent submission. This why DDP reaches out directly to the company in case anything has changed.

In a few cases, we are unable to obtain financial information for a company's fiscal year. In such cases, we use the data from the most recent fiscal year available.

Limitations

Fiscal Data Availability

For the development of the **Largest 50**, **Next 50**, and **Additional 50** lists, DDP primarily utilized data from the Fiscal Year ending in 2020 (ex: July 1, 2019 - June 30, 2020). Though some FY 2021 fiscal data is available, DDP has chosen to use data from FY 2020 for these rankings, comparing all companies within fiscal year 2020 for consistency.

When FY 2020 data was unavailable, DDP used the most recent fiscal year data. In all cases, FY 2019 was used as the most recent year. For 1 company currently ranked in the **Largest 50**, (Ballet Magnificat! (#49)) the most recent fiscal data available was from 2019. Because the information available for a company may change year to year, any comparisons are subject to variances in the information. While ballet companies, the IRS, and DDP each take every measure to avoid human error, DDP acknowledges the possibility of such error appearing in data obtained from organizations both via the Self Report Survey and IRS Form 990s

Fiscal Year Discrepancies

Companies do not all share the same fiscal year, which may be different from the calendar year. Three examples of different fiscal years are included below. The data contained within Form 990 submissions is reported by fiscal year and not by calendar year. No information within the Form 990 enables DDP to reorganize the data to the same time period across companies. DDP analyzes the data by fiscal year, grouping each company's data according to the calendar year in which each company's fiscal year ends. In this report, company data may account for more or less time during COVID-19.

- New York City Ballet: July 1, 2019 through June 30, 2020 (typical COVID timeframe)
- American Ballet Theatre: January 1, 2020 through December 31, 2020 (maximal COVID timeframe)
- Miami City Ballet: May 1, 2019 through April 30, 2020 (minimal COVID timeframe)¹⁶

Structure of Ballet Companies

The structures of ballet companies in the U.S. vary greatly. Many of the larger companies have a professional company and school. One company, New York City Ballet and its affiliated school, School of American Ballet, are independent organizations. Thus the annual expense data for New York City Ballet does not include the expenses of School of American Ballet.¹⁷ In comparison, smaller companies are more likely to operate both professional company and school under one nonprofit organization. Thus their annual expense data encompasses both professional company and school.

Another company, Dayton Ballet, was excluded from this year's calculations as DDP cannot fully separate or attribute expenses for the professional company alone. The expenses, as stated in their Form 990, cover more than the professional company and affiliated school. To ensure accuracy of overall ranking and calculations, Dayton Ballet was removed from the data.

It should be noted that a number of ballet companies have endowments. DDP will be exploring endowments, and their use during the pandemic, in an upcoming report.

Appendix D: Fiscal Year of all Ballet Companies in Largest 150 Ranking

A fiscal year, different from the calendar year, is a timeframe determined by each company individually. Where some may report on a fiscal year running January to December, others may use July to the next June. Because there are a variety of fiscal year timeframes, each company's expenses are reflective of a different period. The difference in fiscal year reporting can be a contributing factor to overall expense totals and therefore ranking. As this report examines expenses during the height of the pandemic, the data is highly affected by specific fiscal year dates which differ from one company to the next.

The figure below is a listing of fiscal years for 115 of the 150 largest U.S. ballet companies. The remaining 35 company fiscal years could not be extracted and verified by our software.
